BACKGROUND

Q.1 What is AICTE-Student Learning Assessment (PARAKH) Project?

Ans. The AICTE-Student Learning Assessment (PARAKH) project is designed to measure the benchmark levels and gains in academic and aptitude skills by the students in various technical programs and to understand the various factors that affect the skill development of students in Technical Institutes across India.

Ans. No

Q.3 What is Assessment?

Ans. Assessment is a process of collecting relevant information on student learning. It is an integral part of the teaching-learning process.

Assessment is conducted in different phases of the teaching-learning process.

- The Assessment process measures personality, attitude, cognitive, social functioning and intelligence.
- Psychological assessment is the process of testing that uses a combination of tests or techniques to get an idea of persons and their behaviors, personalities, capabilities.
- Some assessments are conducted before the beginning of the teaching-learning process, some are carried out during the process, and others conducted at the end of the instructional process.
- In this process, the teacher is collecting information about intelligence, personality and classroom behavior of a student by using appropriate assessments and check-lists.

Q.4 Do I have to pay any money/fees/cost?

Ans. No, This Assessment is free of cost. Student Learning Assessment (PARAKH) is to developed to evaluate technical students of India for their overall qualitative growth during their Course of study in order to get appropriate employment that best suits students capability.

Q.5 What will I get after taking Assessment?

Ans. After Completion of the Assessment Student will get an Report which carries levels and gains in academic, aptitude skills & Higher Order Thinking Skills to understand the strength and weakness in his learning

Q.6 How many times can I take the Assessment?

Ans. There is NO limit on taking the Assessment. Assessment is a process of collecting relevant information on student learning. It is an integral part of the teaching-learning process. Assessment is conducted in different phases of the teaching-learning process. The more you take assessment more it will be beneficial for your career growth

Q.7 Can I take Assessment in my Local Language?

Ans. Yes, Provisions are available

Q.8 What are the different Modes of the Assessment?

Ans. There are two modes of assessment. 1st is Assessment by Institute/School and Other is Self-Assessment. Assessment by Institute/School is when institute or school assign the assessment to the student within the due course of time.

Self-Assessment is when a student self wants to evaluate himself.

Q.9 Can School children also take assessments?

Ans. Yes, Provisions are there.

Q.10 Can non-technical institutions and their students also take part in Student Learning Assessment?

Ans. Yes, Provisions are there.

Q.11 For participation in AICTE- Student learning Assessment (PARAKH) to whom I have to contact?

- Q.13 I am an Individual not associated with Institute.
 Can I take the Assessment?
- Ans. Yes. As self assessment
- Q.14 Is AICTE-Student learning Assessment (PARAKH) a competition?
- Ans. No, AICTE-Student Learning Assessment (PARAKH) is an Assessment designed to measure the benchmark levels and gains in academic and aptitude skills by the students.
- Q.15 AICTE-Student Learning Assessment Project (PARAKH) is mandatory?
- Ans. No, Student Learning Assessment Project develops strong analytic, communicational, quantitative, application-based, comprehensive, and information skills among the Indian students.
- Q.16 There any valid time for the assessment test?
- Ans. Yes, It is 100 minutes test for 100 questions. Questions are divided into 3 levels of difficulty L1, L2, and L3 as per Bloom's taxonomy.
- Q.17 What are the Eligibility Criteria of the Assessment test?
- Ans. For Self-Assessment, there are no eligibility criteria.
- Q.18 What is the prerequisite information to take AICTE-Student Learning Assessment (PARAKH)?
- Ans. Check the website and check user manual.

Q.19 Do I get Placement after doing the Assessment through AICTE-Student Learning Assessment (PARAKH)?

- Ans. No, Student Learning Assessment Project is to evaluate technical students of India and to assess their overall qualitative and quantitative growth during the study to get suitable employment.
- Q.20 What is the difference between Assessment by the Institute and Self-Assessment?
- Ans. Assessment is taken by the Institute/HOD and Faculty within the curriculum while in self-assessment, you can select the subject in which you want to give the assessment along with emerging areas.

- Ans. A Good Assessment Test gives an equal opportunity to fully demonstrate their learning. By taking Assessment through AICTE-Student Learning Assessment (PARAKH) students will Get better opportunities for suitable employment.
- Q.22 Whether it is Only for AICTE Approved Institutions or their Students and Faculties?
- Ans. No, Even Non-AICTE Approved institute can participate
- Q.23 Why AICTE-Student Learning Assessment (PARAKH) is required?
- Ans. To evaluate technical students of India for their overall qualitative growth during their course of study to get appropriate employment that best suits their capability.
- Q.24 After Assessment what action is to be taken by the Institution?
- Ans. After Assessment Institute can identify the GAPS and work on those GAPS for better assessments in future.





- Q.1 How to Apply for AICTE- STUDENT LEARNING ASSESSMENT (PARAKH) as Institution?
- Ans. Visit https://aslap.aicte-india.org, and go to register page as institutes.
- Q.2 How to Assign Assessment to the student or Faculty?
- Ans. From the "Assessment Tab" Institute can Assign the Assessment to the student or faculty. User manual is provided at aslap.aicte-india.org
- Q.3 AICTE- STUDENT LEARNING ASSESSMENT (PARAKH) is between Student and AICTE. What is the role of Institute?
- Ans. Institute plays key role in AICTE- STUDENT LEARNING ASSESSMENT (PARAKH) project. Institute is responsible for Appointing Nodal Officer, Monitoring the Assessments etc & motivating the students and faculties for the Assessments.
- Q.4 How I can see the performance of my Institute?
- Ans. Through the Institute Dashboard.
- Q.5 How to disable faculty login?
- Ans. From the "Faculty Tab", Mark Left the institute against the faculty.
- Q.6 How to Disable student Login?
- Ans. From the "Student Tab", Mark Left the institute against the faculty.
- Q.7 What are the roles at Institute login?
- Ans. Can Submit Institute Profile, Add and Remove Faculties, Add and Remove Students, Assign Assessments to the Students/Faculty, Monitor the assessments from the dashboard.

- Q.8 What if Student register himself by my institution?
- Ans. Yes, but only after the approval by the institution from the login, student will be associated with the institute.
- Q.9 What is role of Head of the Institute in ASLAP?
- Ans. Head of the Institute is responsible for monitoring the AICTE- STUDENT LEARNING ASSESSMENT (PARAKH) activities on the portal.
- Q.10 Is AICTE- Student Learning Assessment (PARAKH)
 Project is for AICTE Approved Institutions?
- Ans. No, Technical Institution or University can participate in AICTE- STUDENT LEARNING ASSESSMENT (PARAKH) Project
- Q.11 Whether I can see he comparison with my neighbor Institute?
- Ans. No, but you can see various comparisons at districts, state and country.
- Q.12 Whether Institute have to add each and every faculty detail in ASLAP?
- Ans. Yes, AICTE is adding the faculty data as prefilled. In-case of addition or deletion in between Institute have to do from their login.
- Q.13 Whether student have to add each and every student detail in ASLAP?
- Ans. Yes.
- Q.14 Who is responsible for AICTE- STUDENT LEARNING ASSESSMENT (PARAKH) implementation in the Institute?
- Ans. Head of the Institute and Nodal Officer.
- Q.15 Who will handle institution login?
- Ans. Through, Head of the Institute or nodal Officer.





STUDENT and FACULTY FAQ's

- Q.1 AICTE- Student Learning Assessment (PARAKH) is for which year Degree students?
- Ans. AICTE- Student Learning Assessment (PARAKH) is for every year student during your study in Degree.
- Q.2 AICTE- Student Learning Assessment (PARAKH) is for which year Diploma students?
- Ans. AICTE- Student Learning Assessment (PARAKH) is for 1st year onwards student during Diploma.
- Q.3 Can a pass out student also opt for AICTE-STUDENT LEARNING ASSESSMENT (PARAKH) assessment?
- Ans. Yes, pass out student can also give AICTE-STUDENT LEARNING ASSESSMENT (PARAKH) Self-Assessment but assigned assessment is open for students approved by institute only.
- Q.4 Can a student his/her survey from his home also?
- Ans. Yes, a student can give his AICTE-Student Learning Assessment (PARAKH) from his/her college or from his home.
- Q.5 Can a student login and opt for multiple assessments from two different devices?
- Ans. No, one student cannot login from two devices at one time.
- Q.6 Can a student opt for two assessments at one time?
- Ans. Yes, student can opt for assessment of his/her own discipline and Computer Science or Emerging Area Assessment at one time, but Discipline assessment must be approved by the institute.
- Q.7 How can a student receive his/her outcome of the AICTE- Student Learning Assessment (PARAKH)?
- Ans. Student Report of the AICTE- Student Learning Assessment (PARAKH) can be seen on the student dashboard and can be generated/downloaded at the end of AICTE- Student Learning Assessment (PARAKH).
- Q.8 How long is the assessment for any discipline?
- Ans. For every assessment student have to complete the assessment in 100 minutes.
- Q.9 How many questions I will be assigned per assessment?
- Ans. For every assessment student will be assigned 100 Questions
- Q.10 I am registering as a student for ECE discipline, I am providing details when submitting showing an error "you are not authorized for registration".
- Ans. Mechanical Engineering student is not allowed to register as ECE student, additionally you can give assessment for Computer Science or Emerging Area only.

- Q.11 Is there any negative marking in AICTE-STUDENT LEARNING ASSESSMENT (PARAKH) assessment?
- Ans. No, there is no negative marking for AICTE-STUDENT LEARNING ASSESSMENT (PARAKH) assessment, as it is not the Exam but an assessment
- Q.12 Is there any time assigned for completing the assessment?
- Ans. Yes, an assigned assessment must be completed within the assigned date and time by your Institution.
- Q.13 The assessment can be halted by the student in between is possible?
- Ans. No.
- Q.14 What are the parameters considered for approval of the Student to take assigned Assessment?
- Ans. 1. Student has to be from AICTE approved Institute
 - 2. Should have PID of the Institute
 - 3. Your HOD has to approve your registration for a particular discipline.
- Q.15 The portal is not allowing me to login as a student.
- Ans. If you are an external student please login for self-assessment, for assigned assessment only Institute can allow you to become part of ASLAP.
- Q.16 What is the format of documents (photograph, college ID, Signature) allowed to be uploaded on AICTE- STUDENT LEARNING ASSESSMENT (PARAKH) portal?
- Ans. The format of all the documents to be uploaded on AICTE- STUDENT LEARNING ASSESSMENT (PARAKH) portal has to be in JPEG, JPG, PDF format.
- Q.17 What is the next step after I Register on AICTE-STUDENT LEARNING ASSESSMENT (PARAKH) portal?
- Ans. Your registration details will be shared with HOD of your department and after receiving approval of the HOD you will applicable to take an assessment
- Q.18 Who all are authorized to assign the assessment to students?
- Ans. An assessment can be assigned by Institute, HOD or Faculty of your discipline.
- Q.19 Why should I participate in AICTE- Student Learning Assessment (PARAKH)?
- Ans. AICTE- STUDENT LEARNING ASSESSMENT (PARAKH) is the program / platform that will help you in understanding the levels and gains in academic and higher-order thinking skills during your study and improve the Quality of your skills for better employability in your future.

NODAL OFFICE BASED QUERIES



- Q.1 Can I also take the self-assessment as faculty?
- Ans. Yes, you can take the assessment, From the "Faculty Assessment Tab" in the institution login
- Q.2 Can I view the score of our institute or only for a department?
- Ans. Yes, From the dashboard tab of the institution login, All the assessment related data is provided
- Q.3 Can I view the score the other institute in my region.
- Ans. No, You can view the score of your institute only.
- Q.4 I am working in ECE department as Assistant professor, Can I also be a the nodal officer.
- Ans. Yes, Any Responsible faculty of the institution can become Nodal officer to sincerely coordinate the ASLAP.
- Q.5 In an institute how many nodal officer as required.
- Ans. Only one is required but for your need you can assign the work to assistant coordinators.
- Q.6 Some students don't have college ID can they register as student.
- Ans. College ID is compulsory for registration.
- Q.7 Some student's information is wrongly filled by the institute, from where I can change it?
- Ans. As the admin right with the nodal officer and change the details, but student can't change the information by its end.
- Q.8 Can I modify the details filled by the students in student form.
- Ans. As the admin right with the nodal officer can change the details, but student can't change basic information by their end.
- Q.9 For how many years, I can be a nodal officer for an institute.
- Ans. It all depends on the institution policy.
- Q.10 From where I can view How many students has filled the registration form.
- Ans. It all depends on the institution policy.
- Q.11 From where I can view How many students has filled the registration form.

- Ans. Please visit "Student Tab" in the institution login.

 All the student related information will be shown there.
- Q.12 How I can register myself as nodal officer for an institute?
- Ans. First institute login in the portal and in the Nodal tab you can register yourself.
- Q.13 I want to change my personal details what is method to do this.
- Ans. By editing profile in the institution login, you can change the details.
- Q.14 If I change my college/Institute Whom I need to inform?
- Ans. Please contact Head of the Institute and handover institute credentials to him/her
- Q.15 If I want to change my registered email id what is the procedure for the same?
- Ans. From the institute login, Nodal officer details can be changed
- Q.16 In the registration process some students faces some challenges whom we need to contact.
- Ans. Write a mail to slapproject@aicte-india.org
- Q.17 Is there any last date to fill all the details of the students.
- Ans. As such no last date to submission and will be informed time to time.
- Q.18 Some students don't want to take assessment. Is it compulsory to take the assessment from AICTE?
- Ans. Nodal officer is a Single Point of Contact (SPOC) for entire project. He has to follow the schedule provided by AICTE and Inform AICTE in case of any difficulty during the entire process. Feedback or raise grievance in case of any issue or any suggestion for development of SLA project. Appoint a coordinator for assistance. Mentor & Motivate Students and Faculties to participate in the Assessment Test.
- Q.19 What is the procedure when I want to change my official details?
- Ans. You have to send the request to Head of institute and they can modify it.
